### **I. Minutes**

March 27, 2009 minutes was accepted as read.

### **II. Financial Report**

Lauren Greenberg presented the proposed budget. Greenberg clarified the question mark under the State Conference line item which account should money goes to.

Deb Stone moved to allot funds from State Conference of \$3,300 to the general fund. Seconded. Carried.

Deb Stone moved to increase from \$50 to \$350 on National Conference line item. Seconded. Carried.

Victor Brown moved to accept the Proposed Budget as revised. Seconded. Carried. 19-7 Holly Wilson called for a Division of the Assembly. 15-12 Carried.
